OVERVIEW

Bio-cultural diversity has emerged as an important component of education for sustainable development (ESD). ESD principles like value orientation, transformative education, cooperation, problem solving, participatory action, holistic perspectives and self-organization are integral for conserving, revitalizing and sustainably using biological and cultural resources. At the same time, looking at bio-cultural diversity through the prism of learning offers a perspective that mutually reinforces strategies of both areas.

This side event highlights cross-sectoral, multistakeholder partnerships, good practices and pilot models that successfully engage communities in the sustainable use or conservation of local biocultural diversity. A multiplicity of contextualized development strategies through educational interventions make the RCE network a unique place for showcasing how local stakeholders can synergize actions under a common umbrella for collective action towards bio-cultural diversity. The network also portrays the relevance of a local-global space for concerted action and understanding of biocultural diversity beyond localized geographical boundaries.

To date, UNU has acknowledged 101 RCEs globally. More than 50 RCEs are working on bio-cultural diversity. Case studies from various continents demonstrate the relevance of RCE projects especially within the broader mandates of effective implementation and awareness of the Convention on Biological Diversity. Five case studies from various Asia-Pacific RCEs will be presented at the side event.
